Chicago Public Schools' Office of New Schools (ONS) is committed to creating new and innovative schools that will provide high-quality educational options to serve the diverse needs of Chicago's public school students. ONS works to recruit, develop, and support new schools and, ultimately, hold them accountable to high performance measures. At the moment, ONS manages a portfolio of 86 schools that consists of charter and contract schools developed through Renaissance 2010 and all charter schools opened prior to 2005. Its partners are the Illinois Facilities Fund, the Renaissance Schools Fund, the Illinois Network of Charter Schools, and SchoolWorks. Each of the 86 schools in ONS portfolio falls into one of three categories: charter schools (independently operated public schools that are not subject to the same state laws, district initiatives, and board policies as traditional public schools); contract schools (independently operated public schools under Renaissance 2010), and performance schools (operated by Chicago Public Schools and employing CPS teachers and staff). Contract schools have an advisory body comprised of parents, community members, and staff. In lieu of Local School Councils, performance schools have an Alternative Local School Council (ALSC), which allows parents, community members, and staff to be involved in all aspects of the school's activities. Community involvement is a vital part of Renaissance 2010. Historically, community members have participated in the new school creation process by serving on a Transition Advisory Council (TAC). In 2009, CPS formed TACs in the following communities, Englewood, Riverdale, and South Chicago. TACs facilitate the community outreach process and collect stakeholder input by acting as liaisons in their respective communities. These councils consist of parents, students, aldermen, educators, area residents, school alumni, and representatives from faithbased/community-based organizations. TAC members carefully review proposals for new schools, host community forums, and make recommendations to CPS about the educational option they feel is best suited for the community.
